



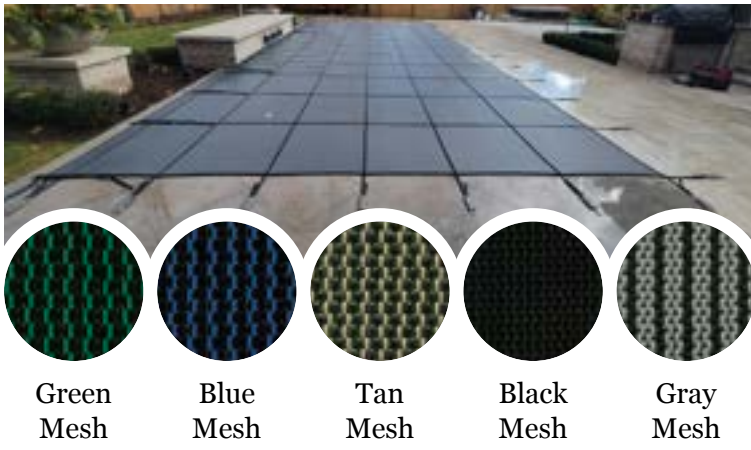

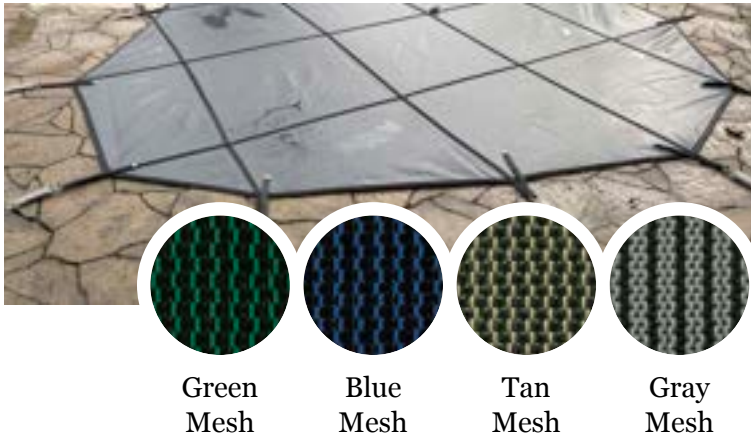

STANDARD MESH

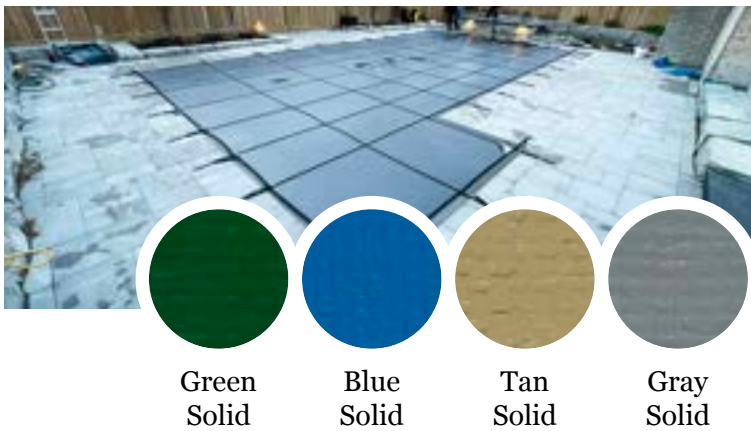

HARDWARE

SPRINGS

All HPI Springs are available with OR without the 'D' Ring attachment. The BlocMesh99 and solid covers ship with the dual barrel spring while the standard mesh covers ship with the single spring. Standard mesh covers can be upgraded upon request! All HPI springs now have the 'Sleeve Saver' plastic clip which will hold the vinyl sleeves in place. No more aggravation at installation, openings or closings!



WALL ANCHORS

Standard wall anchors are 3" long cable OR 'D' Ring holder keeping the cover held tightly to any raised obstruction. This anchor is also available in 6" length upon request.



INTERLOCK (PAVER) ANCHORS

Stainless steel Interlock/Paver stakes are 9" long. 18" long anchors are available by request. Stakes come with the brass anchor already installed in the top.

Perimeter points feature cross-stitched reinforcement. Specially treated, U.V. resistant polyester thread is used throughout the cover.



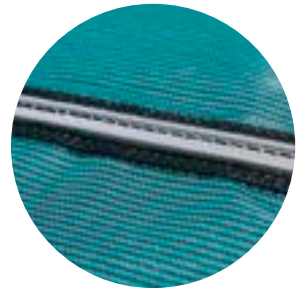
SOLID CONNECTIONS

In order for the warranty to be valid the below warranty card must be filled out and returned within 30 days.

Hinspergers Poly Industries Ltd. (“Warrantor”) hereby warrants to the purchaser of its pool cover that the pool cover is free from defects in material and workmanship appearing within the applicable warranty period when used under normal conditions in accordance with Warrantor’s specifications. The warranty period starts on the date of purchase or installation, whatever is earlier. If a defect in material or workmanship is discovered, the warranty will, at its discretion, repair or replace the pool cover (if the defect is discovered within 24 months of the commencement of the warranty period). Or provide the purchaser with a discount towards the purchase of a replacement pool cover in accordance with the table set forth below (if the defect is discovered subsequent to the 24th month following commencement of the warranty period). Labor costs arising out of a warranty including but not limited to removing or installing products or any other cost related with the warranty claim other than the part are not included and are at the purchaser’s sole expense. Any defective covers replaced or tendered for discount on a replacement cover pursuant to this limited warranty shall become the property of Warrantor upon shipment of the replacement cover.

EXCLUSIONS, CONDITIONS, LIMITATIONS, AND CARE INSTRUCTIONS

THE FOLLOWING ACTIONS WILL VOID THIS LIMITED WARRANTY:

- Failure to maintain pool water at a level which is at least 18' from the top of the pool. This is especially important during snow season as the extra weight may cause damage to the cover and hardware.
- This limited warranty will not apply (a) if the cover is abused or misused; (b) if the cover is altered or modified by any person without the prior written authorization of the Warrantor, including but not limited to, damage caused by purchaser or any other third party, any Act of God, fire, casualty, flood, earthquake, war, strike, lockout, epidemic, riot, insurrection, transportation delays or defaults, action of any governmental authority, or any other cause beyond the reasonable control of the Warrantor; (d) to usual wear or damage caused by animals, hail, snow, ice, system overheating, environmental influence on materials as emitted from animal farms, or chemical plants or similar sources emitting chemicals into the environment of the cover.
- The pool cover is not installed strictly according to the Warrantor's original installation instructions and manuals.
- Utilization of the cover on a pool which is the incorrect size or shape for the cover (i.e., oversized rectangle on a freeform shaped pool).
- Damage to the cover as a result of burn holes from cigarettes, fireplaces or chemicals.
- Damage to the cover caused by animals, tree limbs or act of nature.
- Utilization of the cover for extended or continuous pool closure beyond the winter season (i.e., leaving the cover on the pool for periods greater than 8 months).
- Installation of the cover on a pool at a property that is abandoned or vacant. or without on-site supervision or security.
- Installation of the cover on a pool where more than 10% of the perimeter is installed with a raised wall treatment, interlocking anchors or lawn stakes, or any other installation of the cover which, In accordance with ASTM standards, results in the cover no longer constituting a "safety cover".

CONDITIONS

- This is a swimming pool cover for winter use only.
- The limited warranty provided herein covers the pool cover only. the limited warranty does not cover the pool deck, pool, pool mechanical systems or any other property of any kind whatsoever.
- THE LIMITED WARRANTY PROVIDED HEREIN IS EXCLUSIVE. THE WARRANTOR DISCLAIMS ANY AND ALL OTHER WARRANTIES, CONDITIONS AND OBLIGATIONS TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING, BUT NOT LIMITED TO, ANY AND ALL WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.
- This warranty is conditional upon the purchaser notifying the Warrantor of the defect as follows: (a) A written claim is sent by e-mail or mail to Warrantor at www.hinspergers.com or Hinsperger's Poly Industries, Inc. 430 West Orchard St. Medina, NY 14103 (b) The claim must be received by the Warrantor prior to the lapse of the applicable warranty period; (c) The written claim must include: the purchaser's full name and contact information, the date of purchase of the product, the person from whom the product was purchased, product serial numbers, and a description of the defect; and (d) At least two pictures of the defective product must be sent with the claim. Upon receipt of the claim, the Warrantor will investigate the claim to determine whether there is a defect to be covered by this limited warranty.
- All freight costs incurred when shipping a cover to the Warrantor are the customer. The Warrantor will refund these costs if the claim is valid.

CONDITIONS

- After removal, wash the cover thoroughly with tap water to remove debris or chemicals. Pool chemicals can be extremely harmful to the cover if allowed to remain on the cover.
- Scrubbing is not necessary. Spray with moderate hose pressure on both sides and then dry completely before storage.
- The cover should be stored indoors, such as basement, garage, shed etc., to protect it from the elements and animals.
- With hose pressure, wash each plug and screw to remove any grit or debris.
- Caution: Exposure to the outdoor elements reduces the strength of many components of the cover such as the fabric, thread, webbing etc. Each year added caution should be taken when cleaning and storing the cover. With each year it becomes more important to keep people and animals off the cover.
